Provides protection in the current member states of the EU via a single registration.

We invoice for the filing fees and prosecution fees for a straight forward Application at the time of filing the application.

** Costings are approximate, due to currency fluctuations and exchange rates.

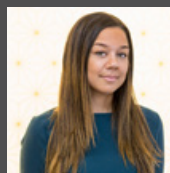
